The 2011 Supreme Court decisions in *Brown v. Goodyear* and *Nicastro v. McIntyre* reined in recent state and federal district courts' expansive and confusing analyses to extend personal jurisdiction over both the non-U.S.

affiliates of U.S. manufacturers and non-U.S. manufacturers with U.S. affiliates. The *Goodyear* and *McIntyre* decisions substantially improve upon the guidance provided by the Supreme Court in the decades since its path-marking *International Shoe v. Washington* decision. Recognizing that *International Shoe* is still alive, Mr. Brogan will explain the practical impact of *Goodyear* and *McIntyre* in the context of the defense of product manufacturers, strategies to avoid needless participation in U.S. based litigation and practice tips for those who find themselves embroiled in U.S. litigation.
